

## **2014 Port City Federal Credit Union Scholarships**

Port City Federal Credit Union awards three \$500.00 Scholarships each year.

### **SmarTeen Scholarship (for graduating high school seniors)**

#### Eligibility Guidelines

- Member in good standing of Port City Federal Credit Union and enrolled in the SmarTeen program
- Minimum grade point average of 2.50 or higher based on a 4.0 scale
- Must have already applied to, and been accepted by, an accredited college, university, or vocational school for the 2014-2015 school year.

### **Advanced Scholarship**

#### Eligibility Guidelines

- Member in good standing of Port City Federal Credit Union
- Minimum grade point average of 2.50 or higher based on a 4.0 scale
- Successful completion of two semesters at an accredited college, university, or vocational school in the previous year.
- Must be enrolled at an accredited college, university, or vocational school for the 2014-2015 school year.

### **Joseph R. Beyrle Memorial Scholarship**

#### Eligibility Guidelines

- Member in good standing of Port City Federal Credit Union
- Minimum grade point average of 2.50 or higher based on a 4.0 scale
- Have submitted a complete application for either a Port City Federal Credit Union “**SmarTeen Scholarship**” or “**Advanced Scholarship**”

#### **All applicants must submit:**

1. Completed application
2. High school or college transcript showing cumulative GPA

#### **Deadline for submission of all materials is April 28, 2014**

All applicant information will be kept strictly confidential. Port City Federal Credit Union may modify or discontinue this program at any time. Selections will be made by an impartial committee appointed by the Port City FCU Board of Directors. Scholarship checks will be made payable to the student and the attending college, university, or vocational school.

#### **Applicants will be notified of the committee’s decision no later than May 2, 2014**

Note: Employees of Port City FCU, their immediate family members, or those living in the same household are not eligible
