Just file it! Gives Free Access to Tax Preparation Services

January 17, 2012, will kick off the **Just file it!** program for the 2011 tax season. Every year, this program helps thousands of Michigan residents file their taxes for free and take advantage of state and federal tax credits including the Earned Income Tax Credit (EITC). Last year, 6,720 Michigan credit union filers received more than \$13 million in tax refunds and credits.

The **Just file it!** program is available to anyone in need of tax services no matter what their income level. All that is required to use the **Just file it!** program is a computer, internet access, a web browser, and a printer. The program uses a free, web-based software program, posing questions to users and offering assistance via online chats. It is offered in English, Spanish and Vietnamese.

All you need to do is click on the **Just file it!** link on the homepage of our website (*this link* will be available on our website beginning January 17).

Tax-Time TIPS

- Save these forms: We will soon be mailing out IRS Forms 1099 and 1098, which report dividend and interest information. If you receive these forms, please be sure to save them for your tax preparation.
- Request Direct Deposit: Complete the Direct Deposit line on your tax form, and your refund will be deposited into your Credit Union account in as little as 10 days. Our routing and transit number is listed on the left side of this page.
- Finish your 2011 IRA: You have until April 17, 2012, to make 2011 contributions. Please contact the Credit Union if you have any questions or concerns.

Treasury Ends Over-The-Counter Sales of Paper U.S. Savings Bonds

Effective January 1, 2012

In an action that will save American taxpayers approximately \$70 million over the first five years, the U.S. Department of Treasury has ended the over-the-counter sale of paper savings bonds at financial institutions. Savings bonds are not, however, going away altogether. Electronic savings bonds in Series EE and I will still be available to purchase through TreasuryDirect.®

What is TreasuryDirect®? TreasuryDirect[®] is a secure, web-based system operated by Public Debt – where investors have been purchasing savings bonds since 2002. Available 24/7, TreasuryDirect[®] is an easy and convenient way to purchase and manage savings bonds free of charge.

What you need to know:

- If you currently hold paper savings bonds, you can continue to redeem them at financial institutions.
- Bonds, which have not matured, but were lost, stolen or destroyed, can be reissued in either paper or electronic form.
- Series I paper savings bonds will remain available for purchase using part or all of one's tax refund please visit www.irs.gov for more information on this feature.
