

Gives Free Access to Tax

Preparation Services

Just file it!

We'll help. program for the 2010 tax season. In past years, this program has helped thousands of Michigan residents file their taxes for free and take advantage of the state and federal earned-income tax credit (EITC). Last year 6,376 Michigan filers received more than \$13 million in tax refunds and credits.

Michigan residents miss out on millions of dollars in tax refunds and credits every year, and Just file it! serves those who need these funds the most. The program is one of many initiatives non-profit credit unions have spearheaded to better serve their members.

The Just file it! program is available to anyone in need of tax services no matter what their income level. All that is required to use the Just file it! program is a computer, Internet access, a Web browser and a printer. The program uses a free, Web-based software program, posing questions to users and offering assistance via online chats. It is offered in English and Spanish.

All you need to do is click on the Just file it! link in the home page of our web site (this link will be available on our website on January 14th.)

Member Tips: Be on the lookout for Financial Fraud

Can you trust that person who just called you out of the blue? Should you respond to that email warning that your account has been compromised? Do you have some doubts about a website that promises to fix your financial problems for a "small" fee?

If you have a feeling something just isn't right, proceed with caution. Many scams try to get you to act quickly, before you have a chance to really think. But remember, if something sounds fishy or too good to be true, it probably is. Don't be afraid to trust your instincts.

If you're leery about an organization, don't hesitate to contact them directly and ask for specific information before you proceed. It's always better to be safe than sorry.

Tax-Time Help

Save these forms: We will soon be mailing out IRS Forms 1099 and 1098, which report dividend and interest information. If you receive these forms, be sure to save them for your tax preparation.

Request Direct Deposit: Complete the Direct Deposit line on your tax form, and your refund will be deposited into your Credit Union account usually in as little as 10 days. Our routing and transit number is listed on the left side of this page.

Finish your 2010 IRA: You have until April 15th to make 2010 contributions.
