

- Make final IRA contributions for 2023. You have until April 15, 2024, to contribute to your 2023 IRA. Please be sure to specify that you are making a 2023 contribution.
- File electronically. Electronic returns are safe, secure, and processed faster than paper returns, so you can rest easy knowing your taxes are filed safely and promptly. Plus, if you're expecting a tax refund, you can expect to receive your e-return several weeks sooner than if you were to file by mail.
- **Choose direct deposit.** You can choose to have your refund split between multiple accounts, making it easy to automate your savings. Simply provide your credit union account number(s) and our routing number: 272483060.
